RESOLUTION OF THE BOARD OF DIRECTORS

ATS INVESTMENT GROUP JOINT STOCK COMPANY

- Pursuant to the Enterprise Law No. 59/2020/QH14 passed by the 14th National Assembly of the Socialist Republic of Vietnam on June 17, 2020, amendments and supplements and implementing guidelines;
- Pursuant to the Securities Law No. 54/2019/QH14 passed by the 14th National Assembly of the Socialist Republic of Vietnam on November 26, 2019, amendments and supplements and implementing documents;
- Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities and implementing guidelines;
- Pursuant to the Charter of organization and operation of ATS Investment Group Joint Stock Company (“Company”/ “ATS”/ “Issuing Organization”);
- Pursuant to Resolution of the 2025 Annual General Meeting of Shareholders (“AGM”) No. 01/2025/NQ-DHĐCĐ-ATS dated April 8, 2025 of ATS Investment Group Joint Stock Company; Submission No. 11/2025/TTr-HĐQT dated April 8, 2025 on approving the plan to offer shares to increase the Company's charter capital;
- Pursuant to Resolution of the Board of Directors (“BOD”) No. 05/2025/NQ-HĐQT-ATS dated June 27, 2025 approving the implementation of the plan for the private placement of shares to increase the Company's charter capital and other related contents;
- Pursuant to Resolution of the Board of Directors No. 06/2025/NQ-HĐQT dated June 30, 2025 approving the registration dossier for private offering of shares;
- Pursuant to the Minutes of the Board of Directors meeting of ATS Investment Group Joint Stock Company No. 07/2025/BBH-HĐQT-ATS dated 09/09/2025.

RESOLUTION:

Article 1. The Board of Directors approves the list of professional securities investors expected to participate in the ATS private placement of shares, as detailed in Appendix 01 attached to this Resolution. This list replaces the list of professional securities investors in Appendix 01 of Resolution No. 05/2025/NQ-HĐQT-ATS of the Company's Board of Directors.

Article 2. The Board of Directors approves the plan to ensure that the issuance of shares meets foreign ownership regulations (replacing the plan to ensure that the issuance of shares



meets foreign ownership regulations in Article 6 of the Company's Board of Directors Resolution No. 05/2025/NQ-HĐQT-ATS).

The plan to ensure that the issuance of shares meets the specific foreign ownership regulations is as follows:

- The maximum foreign investor ownership ratio at ATS is 0% of charter capital according to Document No. 224/UBCK-PTTT dated March 14, 2025 of the State Securities Commission on the dossier announcing the maximum foreign ownership ratio of the Company.
- According to the announcement on foreign ownership ratio on September 9, 2025, at the Vietnam Securities Depository and Clearing Corporation (VSDC) (date of announcement: September 8, 2025), the number of shares held by foreign investors in the company is 4,200, corresponding to 0.12% of the company's charter capital. The company always complies with the regulations in Clause 5, Article 139 of Decree No. 155/2020/ND-CP, ensuring that the foreign ownership ratio in the company does not increase.
- To ensure that the Company's maximum foreign ownership ratio remains 0%, the Board of Directors shall implement the following safeguards:
 - + The Board of Directors has selected and approved the list of professional securities investors expected to participate in the Company's private placement of shares as domestic professional securities investors (detailed information about the investors is specified in Article 1 of this Resolution).
 - + In the case of distributing unsold shares due to professional securities investors who intend to participate in buying shares refusing to buy part or all of the shares in the offering (unsold shares), the Board of Directors commits to only distribute these unsold shares to other domestic professional securities investors.

Therefore, the company's private placement of shares will not increase the foreign ownership ratio, ensuring compliance with the regulations in Clause 5, Article 139 of Decree No. 155/2020/ND-CP.

The Company's Board of Directors commits to always ensure compliance with the regulations on the Company's maximum foreign ownership ratio before, during and after the offering of 0%.

Article 3. Decision to approve the amendment of Point e, Article 3 of the Company's Board of Directors Resolution No. 05/2025/NQ-HĐQT-ATS in Article 3 of this Resolution and replace Point e, Article 3 of the Company's Board of Directors Resolution No. 05/2025/NQ-HĐQT-ATS. Content of Point e, Article 3 of the Company's Board of Directors Resolution No. 05/2025/NQ-HĐQT-ATS after amendment:
